# Join the International Urban Cooperation (IUC) Program

## Start city-to-city cooperation!

## How can US cities be involved and apply?

Cities in the US who wish to be paired with a city in the European Union facing similar challenges on their path to achieving sustainable urban development are encouraged to apply for the International Urban Cooperation (IUC) city-to-city cooperation program.

US cities with more than 100,000 inhabitants are eligible to apply.

The program aims to foster links between cities in the United States and the European Union. Through the program, cities will be able to connect and gain new perspectives on pressing issues in sustainable urban development. To find out more about sustainable urban development policies and programs in the EU see the EU <u>Urban Agenda</u> and <u>URBACT</u> program which fosters sustainable integrated urban development in cities across Europe.

In this first call, we are aiming to identify two EU-US city pairings. The two successful US cities will be paired with an EU city tackling related challenges in sustainable urban development, allowing the pairs to build cooperation and share knowledge. This cooperation may help reduce the costs for cities tackling these challenges independently or in isolation. Representatives from each city will take part in study tours, staff exchanges, trainings, and seminars. The two cities will together develop Local Action Plans that are informed by their exchanges.

By joining the IUC city-to-city cooperation, your city will:

- **COMMIT** Cooperate for a minimum of 18 months with your European peers and allocate sufficient resources and time to develop successful cooperation which will last beyond the lifetime of this program. There is no maximum length for the city-to-city pairing, but participating cities will only receive support for up to 18 months.
- LEARN Exchange views on new ways of approaching challenges and benefit from a wider pool of good practices to draw upon; receive support in identifying innovative business models for financing local action.
- SHARE Help others to solve issues by sharing your own experiences and knowledge.
- EXCHANGE Open your city to dialogue and partnership with new peers in the EU, and relevant stakeholders
- **SHOWCASE** Increase the profile of your city's or region's best practices and achievements internationally.
- **IMPLEMENT** Work with new partners to make your vision of sustainable urban development a reality through developing a Joint Local Action Plan for sustainable urban development in a sector of your choice.

#### What are cities committing to?

Chosen US cities must commit to cooperating intensively with their partner EU city for at least 18 months, and to share their progress with the partner city, the IUC program and as appropriate with the wider public. Cities also agree to develop a Local Action Plan on an identified thematic priority in sustainable urban development. Afterwards, cities commit to reporting on their progress and on concrete actions to be carried out in the future. The cities involved in the pairing will sign a Partnership Agreement.

The Local Action Plans will follow a common methodology to be determined jointly by the cities. One possible methodology is the <u>EU-funded URBACT program</u> which involves more than 550 cities. Local Action Plans should be developed through an inclusive multi-stakeholder process.

Each city will develop its own Local Action Plan, and the plan must include activities and economically viable pilot projects that are capable of being realized within the duration of the pairing. It should aim at opening up market opportunities and encouraging the involvement of research, businesses, other levels of government and the local community to ensure sustainability of the proposed actions in the longer term.

Participating cities will become part of a larger international community of peers and stakeholders engaging on sustainable urban development through the International Urban Cooperation initiative.

To ensure a successful exchange and roll-out of measures and actions, cities need to commit an adequate amount of time and resources sufficient both to implement the work and achieve the ambition of the actions planned.

Measures and actions to be implemented should aim at contributing to achieving the objectives of the UN 2030 Agenda Sustainable Development Goals (SDGs), the New Urban Agenda, the Sendai framework and the Paris Agreement, enhancing quality of life in urban areas.

#### Stakeholder Involvement & Metropolitan Areas

Mobilizing a critical mass of diverse stakeholders and key partners (e.g. academia, civil society, business partnerships) working at different levels is a crucial component for the successful development of a Local Action Plan through the planning, roll-out, and implementation of the plan.

In order to increase the reach and impact of this city-to-city pairing, we are encouraging the pairings of metropolitan areas which may include a number of local authorities working together and coordinating the governance of their respective constituencies. Applying as a metropolitan area (e.g. a larger city coordinating the pairing in partnership with smaller local authorities in the area) would be considered an added value.

#### **Previous cooperation with EU Cities**

Does your city already have strong partnerships with cities in the EU? Do you have a history of successful cooperation with an EU city? If so, that's considered an added value for this initiative.

The call for applications for EU cities to participate is already open. More information is available on the <u>IUC global</u> <u>website</u>, and the <u>application for EU cities is available here</u>. *The deadline for EU cities to apply through this separate process is Thursday 21 September*.

US cities will be paired with an EU partner city after each respective selection process concludes.


